Subject: Review of commercial driveways crossing boulevard multi-use paths

1.0 PURPOSE:

To respond to the City of Oshawa request for comments on which driveways serving commercial businesses should have "Low Volume Driveway Treatment" and which should have "High Volume Driveway Treatment" when they cross a multi-use path in the boulevard.

2.0 COMMERCIAL DRIVEWAY TREATMENTS:

The Ministry of Transportation has recommended Low and High Volume Driveway Treatments as shown on Exhibit 1 below.

Some driveways have obstructed view of the path and path users. It is recommended that these driveways be painted as a High Volume Driveway and that a mirror be erected beside the driveway to provide the motorist with a view of users of the multi-use path as they approach the driveway.

Some entrances are designed as roads. Where necessary, these private roads should be painted as Cross-rides.




Figure 6.71 - Low-Volume Driveway Treatment, In-Boulevard Facility (Multi-Use Path)




Figure 6.72 - High-Volume Driveway Treatment, In-Boulevard Facility (Multi-Use Path)
