# **Tree Giveaway Working Group Report**

The tree giveaway working group has chosen the 21<sup>st</sup> of September as the date for our annual tree giveaway.

The decision has been made to follow the same format as the past few years.

It will be held in City parking lot at the south west corner of King Street West and Queen Street. We will need 5-7 volunteers for the giveaway. Trees are unloaded at 8am, and set up from 9 until 10am.

We are counting on the City to promote the giveaway on their website. The trees will be allocated on a first come first serve basis.

Typically, about a third of people who reserve trees don't pick them up. In the past couple of years, we have encouraged people who wanted more trees to come back in the afternoon. In this way we found a home for all the trees.

We will be offering 3 tree species

- -White Oak
- -Sugar Maple
- -Paper Birch or white pine

#### Overview:

- Approximate date of the event: October 10th, 17th, or 24th
  - We chose these dates as we think a Thursday evening would be a time where people might be more likely to leave their homes.
- Budget Allocation for the event: \$2000
  - Venue \$250
  - Film Royalty \$?
    - Potentially free as we could stream it free on CBC Gem
  - Door Prizes \$500
  - Advertising \$1250
    - This can allow for more creative ways of advertising the event
- Venue: Regent Theatre
  - We are hoping to set up a food drive again this year.
- Film Selection: The Climate Baby Dilemma
  - We are thinking of doing a Q/A discussion period following the film. We will lead a discussion with audience members about the film or related topics in the style of a community town hall. Note that the film is only 44 minutes long, so this leaves plenty of time to hold this session. We all shared the sentiment that previous film nights ended rather abruptly, with everyone simply leaving after the show. We think it could be a great opportunity to engage with the

community and capitalize on the transformative power of the film. Please let us know your thoughts on this idea.

# Road Salt Working Group Report for O.E.A.C. Meeting February 6, 2024

#### Report:

- On January 30, AJ and Joe held a meeting with Isabel Savransky (Sustainability and Asset Planner, Ontario Tech University) and Dr. Andrea Kirkwood (Associate Professor, Ontario Tech University). Dr. Kirkwood has previously presented to O.E.A.C. on her lab's research on road salt environmental impacts. A few key takeaways from the meeting:
  - a. Shared concerns regarding salt application from private contractors; it was suggested to make a business case of the issue
  - b. Isabel said she would look into funding for a pilot study of slips/falls at the university in comparison with amount of salt used, which could be conducted by an environmental class
  - c. Look into slip/fall lawsuits from the City
  - d. Strengthen the case for more public education
  - e. Unite environmental groups around the issue
- Pending approval from City Council, AJ will be presenting on road salt impacts and the importance of forming working groups on this issue to the Durham Environmental and Climate Advisory Committee in March. The working group will be preparing a slide deck and talking points for this presentation.
- 3. The working group intends on meeting in February to discuss our goals and workplan for the rest of the year.
