Re: Information from Oshawa City Council – April 29, 2024

At its' meeting on April 29, 2024, Oshawa City Council adopted the following recommendations of the Corporate and Finance Services Committee:

1. CF-24-24 2024 Oshawa Accessibility Award Nomination (Previously OAAC-24-12)

That in accordance with Report CF-24-24 (formerly OAAC-24-12) concerning the 2024 Accessibility Award Nominations, dated March 15, 2024, the Chair, O.A.A.C. and the Director, Innovation and Transformation recommends that the Canadian Blood Services – Oshawa Blood Donor Clinic be nominated for the 2024 Accessibility Award.

2. CF-24-32 Electronic Participation for the Oshawa Accessibility Advisory Committee Members (All Wards)

Referred to staff to review the Sections of Council's Procedure By-law related to Electronic Participation and report back to Council with proposed amendments; and,

Add a section regarding Electronic Participation to the Advisory Committees of Council Policy and Procedure, including timelines for notifying Legislative Services on requests to participate electronically and report back to Council; and,

That in the interim, notwithstanding Council's Procedure By-law, members of Council requesting to participate electronically provide a minimum of one hour's notice before the start of the meeting and members of Advisory Committees requesting to participate electronically provide a minimum of 1.5 hours' notice before the start of the meeting.

Report of the O.A.A.A. Built Environment Subcommittee – May 9, 2024

The O.A.A.C. Built Environment Subcommittee respectfully reports to the Oshawa Accessibility Advisory Committee its Seventh Report.

Site Plan Approval Application for the 374 Farewell Street (BUILT-24-04)

1. That details of the materials used for all paths of travel be identified and designed as per Oshawa Accessibility Design Standards (O.A.D.S.); and,
2. That all paths of travel width be labelled and the clear path of travel of a minimum of 1800 mm is provided; and,
3. That reasonable lighting levels, light should be provided at or beside all ramps, steps and stairs and evenly distributed along the path of travel. Consideration should be given to providing supplementary lighting to highlight wayfinding. Please ensure that lighting fixtures or posts do not encroach in the accessible path of travel; and,
4. That all front entrances be accessible to accommodate a wheelchair and designed as per O.A.D.S.
