

Oshawa has changed over the years, but in many ways, the past and our cultural heritage resources enrich our lives and contribute to the economic vitality of the community.

Heritage Oshawa and the City of Oshawa recognize the following images as illustrations of creative adaptive reuse.

Genosha Hotel

70 King Street East, Designated 2005



The Genosha Hotel opened in 1929 and is now called 70 King, home to several businesses and residences.

Memorial Park

110 Simcoe Street South, Designated 2024



Home to the City of Oshawa War Cenotaph and the McLaughlin Band Shell. Memorial Park is a major landmark in downtown Oshawa and is used as a beautiful public park and place to gather and remember.

Oshawa Executive Airport

1000 Stevenson Road North, Designated 2021



The Oshawa Airport and Flight Training School is now the Oshawa South Field Heritage Conservation District within the Oshawa Airport.

Oshawa House Hotel

66 King Street West, Designated 2020



Built in 1838, the Oshawa House Hotel is now home to businesses and residences.

Regent Theatre

50 King Street East, Designated 2021



Built in 1919 and now used both by the community and the Ontario Tech University as part of its downtown Oshawa Campus.

Parkwood Estate

290 Simcoe Street North, Designated 2000



The home of Col. R. S. McLaughlin was constucted between 1915 to 1917 is a National Historic Site of Canada open to the public, and host to many movie and television productions.

Simcoe St. Church

66 Simcoe Street South, Designated 2002



Simcoe St. Church was constructed in 1867 and welcomed congregations until April 2024. It is also Back Door Mission and Mission United who provide supports for those experiencing homelessness.
